Regular Council Meeting City of Tallulah March 25, 2021

A regular council meeting was held on Thursday, March 25, 2021, at 5:30 P. M., in the Council Room Chamber of Tallulah City Hall.

Mayor Charles M. Finlayson called the meeting to order, led the Pledge of Allegiance, and allowed time for silent prayer.

During the time allowed, there were no comments from the public regarding items listed on the agenda.

Motion and second to approve minutes of the March 11, 2021 meeting were made by Councilmembers Whitney and Day respectively and carried unanimously.

Section 8 Housing coordinator, Merunda Brown, gave a briefing on the latest activities and accomplishments of the housing program. She also stated that new invitations will be mailed out to applicants due to voucher terminations.

Councilmember Sims motioned for approval, with second from Councilmember Whitney, of a Resolution recognizing "A 2021 Municipal Water Pollution Prevention Plan," Motion carried unanimously.

Motion and second to approve "A Resolution Supporting April 2021 Fair Housing Month" were made by Councilmembers Sims and Day respectively and carried unanimously.
